Terms and Conditions

HOURS OF OPERATION

Order online thru our Website which is open for business 24 hours a day, 7 days a week. Lumenest Lighting Inc. Of Florida customer service is available toll free at 772)240-0533 from 8:00 AM to 5:00 PM EST Monday thru Friday, excluding holidays, to answer any questions.

MINIMUM ORDER

There is no minimum order requirement. Orders under \$100 are charged a \$15 handling fee.

FREE SHIPPING

FREE SHIPPING - On all orders over \$100 shipped within the Continental United States. Orders under \$100 are charged a \$15 handling fee.

SALES TAX

Lumenest Lighting Inc. Of Florida is located in the State of Florida and is obligated to charge sales tax for delivery within Florida We do not add or collect sales tax for other states - It is the customer's responsibility to pay appropriate sales tax to your state where necessary. Florida Sales tax rates vary by county. Florida tax exempt customers must submit their Florida Exempt Use Certificate or Florida Resale Certificate. to avoid tax. Florida Tax Exempt Customers should email appropriate Certificate at the same time as placing their first order. At checkout make a comment in the Order Comments section stating that Certificate has been emailed or faxed. Lumenest Lighting Inc. Of Florida will file the certificate and deduct the tax from the order. Your tax exempt status will then be profiled in our system; therefore, the tax will not appear at checkout on future orders.

PAYMENT OPTIONS

SHIPPING METHODS

A \$45 Wire Transfer fee will be added to the invoice of all International Orders.

ORDER PROCESSING

ORDER TRACKING

DAMAGED GOODS POLICY

If you receive deliveries that are damaged during transit, contact Lumenest Lighting Inc. Of Florida customer service immediately. to a satisfying and timely conclusion. All products are shipped F.O.B. Factory with title of the merchandise passing to the buyer upon tender of shipment to common carrier. The buyer has responsibility for immediate inspection of goods upon delivery. RETURNS

We will issue an RGA number to return product along with a label and return instructions. Products returned will not be accepted unless Lumenest Lighting Inc. of Florida has provided a RGA number in advance. Once the returned product is received, it will be inspected.
